

# III Photography contest CODEPA

## “Aurora Mas de Gaminde” Memorial

### Nursing and care.



The Nursing College of Asturias opens again the third announcement for the photography contest about Care and Nursing. As in previous years, the aim of this competition is to raise awareness about nurses and care, both in a professional and a human level.

#### **Subject:**

Nurses and care for people and society. Only photographs related to this theme will be admitted.

#### **Participants:**

Only those people (either professional or amateur photographers) who send their work within the required period and in the required format.

The photographs are only to be presented by the author of the piece.

Members of the Governing Body of the CODEPA, members of the Governing Board of Asemeyando, and the jury of this contest, including any family member of the above mentioned, cannot participate in the contest.

#### **Prize categories:**

##### **PRIZES FOR THE THREE BEST PHOTOGRAPHS:**

- Winner image will be awarded 400€ in cash and a CEF golden medal.
- Secondary award consisting of 200€ in cash and a CEF silver medal.
- Tertiary award consisting of 150€ in cash and a CEF bronze medal.

##### **PRIZES FOR THE TWO BEST NATIONAL WORKS:**

- Winning image will be awarded a El Corte Inglés spending voucher, valued at 250€

- Secondary award consisting of a El Corte Inglés spending voucher, valued at 150€

**PRIZES FOR THE THREE BEST PHOTOGRAPHS FROM COLLEGIATE MEMBERS FROM ASTURIAS:**

- Winning image will be awarded an El Corte Inglés spending voucher, valued at 250€
- Secondary award of an El Corte Inglés spending voucher, valued at 200€
- Tertiary award of an El Corte Inglés spending voucher, valued at 150€

**POPULAR PRIZE FOR EXPOSED WORKS BY COLLEGIATE MEMBERS FROM ASTURIAS:**

- Additional prize of a Smart TV (sponsored by AMA Aseguradora), which will vote exhibition visitors among the exhibited photographs of the collegiates.
- Collegiated members could be awarded in every category, but not simultaneously. In such case, most valuable prize will be given to the participant.
- National participants can aim for the first three prizes and the two first prizes in national categories. However, they are not to be awarded in both categories simultaneously. The most valuable prize will be given.
- Non-national participants can compete for the three first prizes.
- The cash prizes object of the contest are compulsorily subject to I.R.P.F withholding tax, at the rate in force at the time of awarding the prize.
- All finalists will receive a diploma and an invitation to the awards ceremony.
- The 15% of works with the highest score in the general category will receive a CEF score. The prizes (prior communication by e-mail or telephone to the winners) will be made public through social media. Moreover, the organization will reserve the right to publish the photographs in magazines, books and other material that could be published with the sole objective of promoting and spreading the image of Asturian nursing and care, as well as this contest, expressly citing its author. There will be no profit in the dissemination of said works.
- All prizes will be chosen by the contest jury, whose decision will be final.
- In the event that a person residing outside of Spain is awarded, the prize will be paid in euros, and transfer costs will be discounted from the prize amount itself.
- **Jury:**
- A qualified jury will be made up of people appointed by the Asemeyando Photographic Association and CODEPA (including a CEF jury) and will select 20 or 30 photos from which the winners will emerge. These works will be exhibited by CODEPA. Additionally, the jury may award special mentions or second prizes to participating works that have a special aesthetic, social or professional interest. In no case will the prize be economic. Second prizes or special mentions will always be decided by the jury itself.
- Those works that do not adapt to the agreed topic or do not adapt to the required format may be rejected.
- The jury's decision will be made in a public and open act and will be final and unappealable.
- **Presentation of works**
- Registration is free.
- The maximum number of photographs submitted by each author will be five (5).

- If photographs taken by the same camera, presented under different names, are found, all the authors involved will be automatically disqualified.
- All essentially photographic genres and procedures are admitted. However, infographics will not be accepted. Images that represent the process of care photography, in any aspect both inside and outside Asturias, will be valued.
- The photographs must be submitted in the media indicated below and within the duration of the contest, which runs from the moment of publication of this call on the CODEPA website and social networks, Asemeyando's Facebook page or on the web [www.exodos.es](http://www.exodos.es) until SEPTEMBER 11, 2022.
- Digital Files. The images must be sent in compressed JPG format, with a minimum size of 5000px on the longest side and a minimum size of 3000px on the shortest side, at 300 dpi, without frames, the image being bleed on the canvas .
- The photographs will be sent in digital format through the fotogenius platform: <https://asemeyando.fotogenius.es/>
- When sending via the platform, the name and postal address of the author, their telephone number, CEF membership number, if applicable, and the indicative caption text for each photograph sent must appear so that the organizer can exercise their right to reproduce the works in their catalogs or the means provided in these bases.
- The participating collegiate, in order to be eligible for all the categories of the contest, must check the box “opt for the collegiate's award”
- The photographs may not have been awarded in any other call for this contest.
- No signatures, frames or texts on the images will be allowed.
- The organization reserves the right to admit works that could threaten the privacy or dignity of professionals, patients or institutions.
- **Exhibition of works:**
  - All the finalist works will be exhibited on the website of the Official College of Nursing of Asturias once the reception period has ended.
  - A selection of finalist images will form part of the sample that will be exhibited at the awards ceremony. This exhibition may be itinerant in order to promote the contest and its message
  - The Official College of Nursing of Asturias will keep a photographic file with all the selected images that may be used for educational, social and promotional purposes of the nursing profession.
- **Deadlines:**
  - Publication of the bases: June 3, 2022.
  - Reception of works: Until SEPTEMBER 17, 2022.
  - Publication of the jury's decision: As of OCTOBER 8, 2022.
  - Publication of photographs selected by the jury: From OCTOBER 15, 2022.
  - Exhibition of works: Pending according to room availability.
  - Popular vote: Pending according to room availability. (It will be in an urn in the center itself)
  - Awards ceremony: From OCTOBER 31, 2022
- **CEF recognition:**
  - This contest has the recognition of the Spanish Confederation of Photography (CEF) and is scored for obtaining the titles of Artist, Excellence and Master of the CEF. For this reason, the contestant grants their authorization to the organizers and

to their higher body CEF, so that their personal data may be processed, always in the exclusive scope of the artistic dissemination of their works, and for the publication of their merits and awards destined for the obtaining CEF distinctions.

- The organizers and contestants submit to the recognition regulations of the CEF and to these rules. If any situation is not contemplated in these regulations, it will be studied by the organization, which may consult with the CEF, and will be resolved by the Board of Directors.
- **Acceptance:**
- Participation implies full acceptance of these rules. Any situation not foreseen in the same will be resolved by the organization, its decision being final.
- **Derechos de imagen y de autor.**
- The author will be responsible of obtaining the authorisation of the people and objects that are being photographed (that require so) for the publishing and broadcasting of the works.
- Participants are to certify and guarantee that the author is exclusively the one that has taken the photo and that the content in them goes not against the law, moral code or public order. El participante certifica y garantiza que
- The works that have been selected and awarded in the contest will automatically assign the right to use the image to CODEPA, Asemeyando collaborators and their higher organizations CEF (Spanish Confederation of Photography) free of charge, to disseminate the submitted works, through its web pages and official profiles on social networks and other media and audiovisual resources of CODEPA and/or that are part of its programming.
- For the use described above, the participants accept that the materials provided to CODEPA may be edited and combined with images, sound, text or any other information and/or effect that CODEPA considers for its publication. The authorization mentioned in the preceding paragraph is granted free of charge and, therefore, the participant accepts that they will not receive any amount for the use that CODEPA makes of the material.
- The organizers and higher bodies are exempt from any liability in the event of claims for image rights by third parties, always non-profit and for the sole purpose of promoting the contest and its message.
- The winners are guaranteed that their name may be mentioned in any commercial, advertising or communication media that CODEPA may use in order to inform and make public the result of the promotion carried out.
- **Acceptance of the bases:**
- Participation in this contest and sending the photographs in accordance with the provisions of these rules implies acceptance of the same and agreement that CODEPA resolves any issue arising from the contest in which it participates, with CODEPA being able , to the extent permitted by law, modify the bases at any time if the circumstances so require. The modification will be announced and will come into force from the date of its announcement, without the contestants being able to make any claim for it, but they may withdraw their works after the modifications.
- **Personal data of a personal nature:**

- In accordance with the provisions of the Organic Law on Data Protection 3/2018, of December 5, we inform you that your personal data and that of the people who may appear in the works that the author submits to this contest (particularly the image), will be processed by the person in charge: Official College of Nursing of the Principality of Asturias (hereinafter CODEPA, C/ Juan Antonio Álvarez Rabanal 7, bajo, 33011, Oviedo) with the entity ASEMEYANDO also being co-responsible, the electronic address of the protection delegate of data is [dpdcodepa@jmconsultores.es](mailto:dpdcodepa@jmconsultores.es).
- The purpose for which the data will be processed is to manage the works submitted to the contest and relate them to each author; promote and publicize the authors who have been nominated or won an award in accordance with the provisions of the Participation Bases; manage the payment of the winning works; being possible its publication in the CODEPA media, Web and social networks.
- The legitimacy of the treatment is given by your consent when registering on the ASEMEYANDO platform, declaring that you have read and accepted the Contest Bases and the Data Protection Policy.
- Once the contest is over, the data will be stored in the computer infrastructure of CODEPA for an indefinite period of time unless you exercise your right of deletion, opposition or limitation.
- CODEPA undertakes to comply with its obligation of secrecy with respect to the data provided and undertakes to treat it confidentially. To this end, the necessary measures have been adopted to prevent their alteration, loss, misuse, alteration, treatment or unauthorized access and/or theft of the data provided.
- In the event that the image contains personal data of persons other than the participant (for example, if it contains portraits), the participant declares that they have informed and have the express, prior and unequivocal consent of each of the participants. Interested parties to carry out the planned data processing, exonerating CODEPA from any claim arising from such non-compliance.
- The affected party may at any time exercise the ARSOPOL rights of the personal data that are processed according to the CODEPA activities registry, requesting it by any means that records its sending and receipt, clearly expressing their wish, accompanying a copy of the DNI and how many documents are necessary to prove your identity, as well as the reasons that justify the exercise of your right. If you exercise any of the opposition, suppression or revocation rights of the consent granted, you will not be able to participate in the contest.
- In the event that you do not consent to the processing of data according to the purposes set forth herein, or the person you have photographed does not consent to the processing and use of their image, in accordance with these rules, do not submit works to the Contest.
- Holders of personal data who understand that their exercise of rights has not been duly attended to, may also file a claim with the Spanish Data Protection Agency.
